The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below:


Upgrade First Aid Statements according to PR Notice 2001-1

Conditions

Revise the label as follows:

- 1. Page 3 and 4: Qualify ceramic tile as a hard nonporous surface by stating "glazed" ceramic tile.
- 2. Page 3: The Agency has determined residential products that list microwave ovens and refrigerators as surfaces for disinfection must either delete the surface(s) or specify "exterior surfaces of microwave ovens and/or refrigerators."
 - 3. Page 4: Since this product kills Trichophyton mentagrophytes, either add the following claim or specific fungicidal directions to the label as follows:

Formula GP is effective against Trichophyton mentagrophytes, agent that causes Athletes Foot Fungus, on hard nonporous surfaces in shower and bath areas. Follow Disinfection Directions.
