Hose on Type Applicator: Thoroughly water areas to be treated. Use one tablespoon of SLUG-FEST Colloidal 25 for each gallon of solution delivered by your applicator to cover approximately 100 sq. ft.

Sprinkling Can: Thoroughly water areas to be treated. Mix one tablespoon of SLUG-FEST Colloidal 25 to each gallon of water and sprinkle over areas to be treated.
