

## DIRECTIONS

For the control of brown patch and dollar spot best control is effected by regular spraying at 7 to 10 day intervals. During weather particularly conducive to fungus disease it may be necessary to spray every 3 to 5 days. Spraying should be started before the earliest probable appearance of disease and continued through the season or until all danger of infection is passed.

For preventive treatment, use 3 oz. or 1 cupful per 1,000 sq. ft.

For curative treatment, use 6 oz. per 1,000 sq. ft.

For the control of snow mold use 8 oz. per 1,000 sq. ft. as late in the fall as possible, prior to snowfall. Spring applications should be 3 oz. per 1,000 sq. ft. applied as soon as the snow melts.

Amount of water—apply with enough water to give complete coverage of area to be treated. 5 to 10 gals. of water per 1,000 sq. ft. Pressure sprayers, or proportioners may be used.

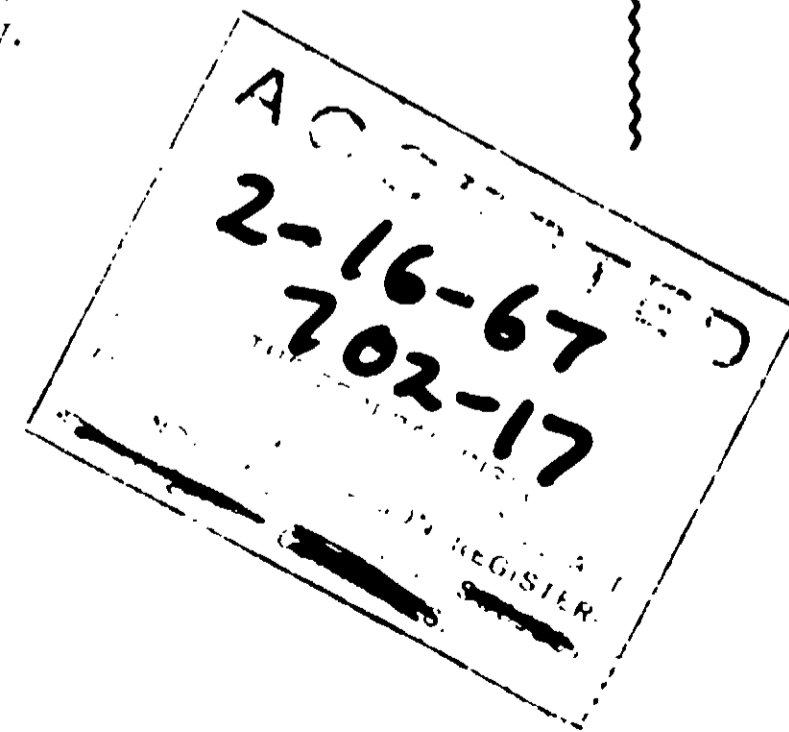
