

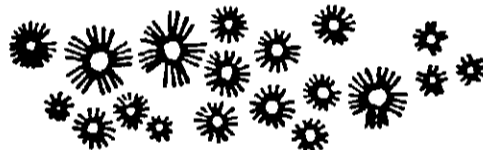

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product
in a manner inconsistent with its labeling.

Shake well before each use. For best results,
container should be at about 70°F (21°C).
Hold can upright, with spray button pointed
away from face and other people. Spray up-
wards, directing spray toward center and
corners of closed room. A 6 to 10 second spray
is usually sufficient for a room of 1,000 cu. ft.

PRECAUTIONARY STATEMENTS

Hazards to humans and domestic animals: do
not spray on or near exposed food. Cover
food handling surfaces and utensils before
spraying, or wash thoroughly after using spray.
Do not spray toward eyes or face. Avoid exces-
sive breathing of spray mist. In case of eye
irritation from excessive contact, immediately
flush with plenty of water. Get medical atten-
tion if irritation persists. If swallowed, induce
vomiting.

Physical or chemical hazards: Contents under
pressure. Do not spray, use, or store near
heat, open flame, sparks, red hot surfaces,
or other sources of ignition and high tem-
peratures. Do not puncture or incinerate con-
tainer. Exposure to temperatures above 130°F
(54°C) may cause bursting.


The amendment referred to above, submitted in connection with registration under FIFRA sec. 3(c)(7)(A), is acceptable provided that you:
