DIRECTIONS FOR USE

TO KILL FLIES, MOSQUITOES, GNATS, WASPS, HORNETS, SAND FLIES, AND STINK BOMBS: Close doors and windows. With a slow sweeping motion, spray toward center of room for 4-6 seconds for the average room (1000 cu. ft.) Keep nozzle at least 3 feet from surfaces. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry.

TO KILL ROACHES, WATERBUGS, SILVERFISH, CRICKETS, ANTS, SCORPIONS, CENTIPEDES, SPIDERS, AND FLEAS: Spray baseboards, cracks, crevices, moist areas, and openings around sinks and pipes and other hiding places, hitting insects directly. Spray ant hills and ant trails around windows and doorsills and other locations. For fleas, thoroughly spray animal quarters and sleeping areas. Repeat as necessary.

TO KILL CLOTHES MOTHS AND CARPET BEETLES: Spray all articles to be protected, giving particular attention to folds and seams. Spray interiors of storage containers such as closets, chests and trunks regularly. Treatment should be repeated every 30 days unless the articles are stored in moth tight containers. **FOR CARPET BEETLES,** thoroughly spray underside of rugs.

TO KILL BEDBUGS: Spray mattresses thoroughly, especially around seams and tufts. Spray bedstead, baseboards and floorboards. Repeat treatment frequently.

CAUTION: If used in a food processing or preparation area, food should be removed or covered during treatment. Food processing surfaces should be covered during treatment or thoroughly cleaned before re use. Do not treat while food processing is under way.

WARNING: Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperature above 120°F may cause bursting. Never throw container into fire or incinerator. Do not spray on plastic, tile or varnished surfaces.
