Dear Mrs. Young:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

#### General Comment(s):

1. Delete all text throughout the subject label that has been marked with "strikethrough."

#### Directions for Use, Use Restrictions subsection comment(s), middle of page 2 of 3:

- To facilitate inclusion of required label language from the REDs for d-Phenothrin and tetramethrin, you must make the following changes:
  - Immediately preceding the 1<sup>st</sup> sentence of the 1<sup>st</sup> paragraph in this subsection, insert the following text to read "Apply this product only as specified on this label. Do not contaminate food or feedstuffs. THIS PRODUCT IS FOR INDOOR RESIDENTIAL/NON-RESIDENTIAL USE ONLY."
  - Within the 5<sup>th</sup> sentence of the 2<sup>nd</sup> paragraph in this subsection, insert the words "like a gutter" immediately following the word "area."

Should Claire Manufacturing Company wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under section 12(a)(1)(E) of FIFRA. 40 CFR §156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not be substantially differ from those claims approved through the registration process. Therefore, should the Agency find, or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA-approved registration, the website will be referred to EPA's Office of Enforcement and Compliance Assurance (OECA). As an alternative, Claire Manufacturing Company may refer consumers to the company's phone number or e-mail address.

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.

### **Physical or Chemical Hazards**

Contents under pressure. Do not use or store near heat or open flame. Do not store in direct sunlight. Do not smoke while using this product. Do not puncture or incinerate container. #### **Use Restrictions**

Do not use in commercial food processing, preparation or storage areas. Do not apply this product in a way that will contact adults, children or pets, either directly or through drift. Only protected handlers may be in the area during application. Do not enter or allow others to enter the treated area until the sprays have dried. Do not allow adults, children or pets to enter treated areas until vapors, mists and aerosols have dispersed, and the treated area has been thoroughly ventilated. Do not use on humans, domestic animals or pets. Remove pets/birds and cover fish aquariums and ornamental fish ponds before spraying, and turn aquarium systems off.

Do not use in food areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served, such as dining rooms, but excluding areas where food may be prepared or held. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries, vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage areas (after bottling or canning). Application is prohibited directly into sewers or drains, or to any area where drainage to sewers, storm drains, bodies of water or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

Do not apply when food is present. In the home, cover all food processing surfaces and utensils during treatment or thoroughly wash before reuse. Cover or remove exposed food.

**To Kill Flies, Gnats, Mosquitoes and Small Flying Moths:** Close all doors and windows, and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Wait 2 hours after application, then open windows, vents and doors for 2 hours. If an odor is still detected, additional ventilation is required. Sweep up and discard fallen insects.

## Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.


