Use Restrictions

Apply this product only as specified on this label. Do not contaminate food or feedstuffs. **This product is for Indoor Residential/Non-Residential Use Only.** Do not use in commercial food processing, preparation or storage areas. Do not apply this product in a way that will contact adults, children or pets, either directly or through drift. Only protected handlers may be in the area during application. Do not enter or allow others to enter the treated area until the sprays have dried. Do not allow adults, children or pets to enter treated areas until vapors, mists and aerosols have dispersed, and the treated area has been thoroughly ventilated. Do not use on humans, domestic animals or pets. Remove pets/birds and cover fish aquariums and ornamental fish ponds before spraying, and turn aquarium systems off.

Wait 2 hours after application, then open windows, vents and doors for 2 hours. If an odor is still detected, additional ventilation is required. Sweep up and discard fallen insects.
