This product is conditionally registered in accordance with FIFRA section 3(c)(7)(A) provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) or 4(a) when the Agency requires all registrants of similar products to submit such data.

2. Make the label changes listed below before releasing the product for shipment:

- a. Add the phrase "EPA Registration No. 706-97" to the label.
- b. Since the data matrix does not provide a dielectrical breakdown voltage, the following statement must be added to the product label:

Do not use in or on electrical equipment due to the possibility of shock hazard.

- c. Expand the sentence under the heading PRECAUTIONARY STATEMENTS to read "After space spraying in food processing plants, wash all food handling surfaces, equipment, benches, shelving, utensils, etc. with an effective cleaning compound followed by a potable water rinse prior to use".

- e. Revise the statement under the ENVIRONMENTAL HAZARDS subsection to read as follows:


Do not contaminate water when disposing of equipment washwaters.

3. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE BEFORE USING AND AT INTERVALS DURING PROLONGED USE.

Hold container upright with nozzle away from you. Press valve down and spray as directed. To avoid possible staining of fabrics or surfaces do not spray at close range.

House Flies, Mosquitoes, Gnats, Wasps and Small Flying Moths (Millers): Close all doors and windows and spray room at the rate of 2 seconds per 1000 cubic feet. Direct spray to all parts of the room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Keep room closed for 10 to 15 minutes after treatment. Repeat as necessary.

Cockroaches, Waterbugs, Silverfish, Crickets, Spiders, Centipedes and Sow Bugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible. Repeat treatment as necessary.

Ants: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

Fleas: Spray sleeping quarters, bedding, floor and floor coverings where pets are kept. Repeat as necessary. Use only a recommended pet spray on pets.

Carpet Beetles: Spray directly on beetles, baseboards, floors, shelves and carpets. Repeat treatment as necessary.

Bedbugs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings and floors. Allow treated fabric to dry thoroughly before using. Repeat treatment as necessary.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from direct sunlight, windows, flames and other sources of heat or ignition. **DISPOSAL:** Replace cap, wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture.

CAUTION: Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. Do not apply directly to food.
