Follow these guidelines when applying Plaze Picaridin Lotion Repellant:

- Apply evenly to skin in a thin layer
- Do not exceed two applications per day.
- Excessive amounts or more frequent reapplication should be unnecessary.
- Do not apply to the hands of small children
- Avoid contact with lips, cuts, wounds, or irritated skin.
- Do not apply to excessively sunburned skin.
- Do not apply under clothing.
- Apply sparingly around ears.
- When using on children, apply to your hands and then apply it to the child. Do not apply to their hands. To apply to a child's face and neck, apply the product into your hands and apply to the child. Take care to avoid mouth and eyes and apply sparingly around ears. Do not allow children to handle the product.
