DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Skane M-8 mildewcide is for use as an industrial mildewcide in coatings, paints, building materials, wallpaper pastes and adhesives, aqueous adhesives and tackifiers and leather.

COATINGS

For use as a mildewcide in coatings such as latex and solvent-based paints, semi-transparent stains and solid stains. Use 1.0 to 3.0 pounds of Skane M-8 mildewcide per 100 gallons of coating formulation. If necessary, a higher dosage up to 4.0 pounds of Skane M-8 per 100 gallons may be used depending upon level of control required.

In latex coatings, Skane M-8 should be added during the letdown phase of paint manufacture. To insure uniform distribution throughout the coating, it is recommended that Skane M-8 be premixed with propylene glycol and coalescent. The premix should be added slowly, with good agitation, just prior to the addition of the thickener. In solvent-based coatings, a coupling solvent such as butyl Cellosolve® may be used to assist in mixing Skane M-8.

CONCENTRATES Skane M-8 should be added to the polymer latex concentrate at a level to ensure that the final use-dilution will contain 1.0 to 3.0 pounds of Skane M-8 mildewcide per 100 gallons of coating formulation. Contain 1.0 to 3.0 pounds of Skane M-8 mildeworde per 100 gamons of country and state of Skane M-8 mildeworde will depend upon the type of formulation, the presence and level of zinc oxide in the system.

WALLPAPER PASTES AND ADHESIVES

For use as a mildeweidal preservative to protect materials such as polyvinyl acetate, starch and dextrin-based pastes from fungal attack after they are applied. Use 0.1 to 0.15 pounds of Skane M-8 mildeweide in 100 pounds of formulation.

AQUEOUS ADHESIVE AND TACKIFIER PRESERVATION

For use as a mildewcidal preservative in water soluble and water dispersed adhesives such as animal glues, vegetable glues, natural rubber latices, polyvinyl acetate, styrene-butadiene, polyurethane, epoxy, acrylic latices, and tackifiers derived from rosin and hydrocarbon resins. Use 0.10 to 0.20 pounds of Skane M-8 mildewcide per 100 pounds of formulation.

LEATHER PRESERVATIVE

Skane M-8 is recommended for the prevention of mold, bacteria, and fungi in the storage and transport of wet leather stock such as pickled, chrome-tanned, and vegetable-tanned leather.

Use Skane M-8 Mildewcide at the levels specified in the following table to prevent microbial growth on processed hides. The level used will depend on storage conditions and the length of protection required. Pre-dilute Skane M-8 45-180 times with water and add the diluted product to the chrome liquor at the start of the tanning process.
