STATEMENT OF PRACTICAL TREATMENT

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FABRIC MILDEWICIDE

To prevent mildew in launderer or treated fabric, use 1 1/4 to 2 1/2 fluid ounces of Kathon LM mildewicide for every 100 gallons of final rinse. Alternatively, use 3/4 to 1 1/2 fluid ounces of Kathon LM in the final rinse for every 100 pounds of fabric treated. Fabric may be retreated as necessary to effect continued mildew protection. Fabric should be re-treated after every laundering.

INDUSTRIAL RECIRCULATING WATER COOLING TOWERS

For the control of bacteria, algae and fungi add Kathon LM microbicide to the tower basin, distribution box or some other point to insure uniform mixing.

INITIAL DOSE: When the system is noticeably fouled, apply 1000-2000 ppm Kathon LM microbicide (8.6-17.2 lbs. or 128-256 fl. oz. of Kathon LM per 1000 gallons of water in the system) Repeat until control is achieved.

SUBSEQUENT DOSE: When microbial control is evident, add 100-1000 ppm Kathon LM microbicide (0.86-8.6 lbs. or 12.8-128 fl. oz. of Kathon LM per 1000 gallons of water in the system) weekly or as needed to maintain control. Badly fouled systems must be cleaned before treatment is begun.

AIR WASHER SYSTEMS

Add to the air washer sump or chill water sump to insure uniform mixing 100-2000 ppm Kathon LM microbicide (0.86-17.2 lbs. or 12.8-256 fl. oz. of Kathon LM per 1000 gallons of water in the system) (depending upon the severity of contamination to control bacteria, fungi and algae which cause fouling in industrial air washer systems)

INTERMITTENT OR SLUG METHOD

INITIAL DOSE: When the system is noticeably fouled, apply 1000-2000 ppm Kathon LM microbicide (8.6-17.2 lbs. or 128-256 fl. oz. of Kathon LM per 1000 gallons of water in the system) Repeat until control is achieved.

SUBSEQUENT DOSE: When microbial control is evident, add 100-1000 ppm Kathon LM microbicide (0.86-8.6 lbs. or 12.8-128 fl. oz. of Kathon LM per 1000 gallons of water) weekly or as needed to maintain control

CONTINUOUS FEED METHOD

INITIAL DOSE: When the system is just noticeably fouled, apply 1000-2000 ppm Kathon LM microbicide (8.6-17.2 lbs. or 128-256 fl. oz. of Kathon LM per 1000 gallons of water in the system).

SUBSEQUENT DOSE: Maintain this treatment level by adding a continuous feed of 100-1000 ppm Kathon LM microbicide (0.86-8.6 lbs. or 12.8-128 fl. oz. of Kathon LM per 1000 gallons of makeup water).

Badly fouled systems must be cleaned before initial treatment.

NOTE: For use only in industrial air washing systems that maintain effective mist eliminating components.

This product is corrosive to mild steel. Do not store or transport in unlined metal containers. Do not contaminate with strong oxidizing or reducing agents. Do not contaminate water, food or feed by storage, or disposal or cleaning of equipment.
