

The amendment, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, to update the product label as PR Notice 2007-4, add an emergency contact number and align the First Aid and Precautionary Statements sections for label consistency, is acceptable, provided you make the following revisions:

Revise the Container Disposal to read as follows:

"Nonrefillable container. Do not reuse or refill the container. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration or by approved state and local authorities".

TREATMENT

Kathon PS is recommended for the control of bacteria and fungal slime in the production of paper.

POINT OF ADDITION

Kathon PS should be added at a point in the system to ensure uniform mixing such as the Beater, Hydropulper or Fan or Broke Storage Pump.

DOSAGE

Apply 0.05 to 0.17 pound of Kathon PS per ton (dry basis) of pulp or paper produced, as a slug dose. If needed, repeat daily. Badly fouled systems should be cleaned before initial treatment.

Kathon PS weighs 10.8 pound per gallon.
