Kathon® CG/ICP Industrial Microbicide is recommended as an in-container preservative for the control of bacteria and fungi in industrial and household consumer products, including all-purpose liquid cleaners, furniture and floor polishes, and anti-tarnish products, air fresheners, carpet shampoos and pre-spotters. Add 0.4-1.5 pound Kathon CG/ICP (181-680 gram) to each 1000 pound (453.6 kilogram) of product to be treated to provide 6-22.5 ppm active isothiazolones.

Kathon® CG/ICP Industrial Microbicide is recommended for the control of bacteria and fungi in liquid dishwashing detergents, automotive appearance products, such as cleaners, waxes and polishes, and liquid laundry products, such as fabric softeners, laundry detergents, pre-spotters and spray starch. Add 0.4-1.0 pound Kathon CG/ICP (181-454 gram) to each 1000 pound (453.6 kilogram) of product to be treated to provide 6-15 ppm active isothiazolones. To insure uniform distribution, slowly disperse Kathon CG/ICP into product with agitation. Mix thoroughly until evenly dispersed throughout product.

Add 0.4 to 1.5 pound Kathon CG/ICP (181-680 gram) to each 1000 pound (453.6 kilogram) of silicone emulsion, surfactant, or water used to pre-moisten sponges and mops.

SILICONE, SURFACTANT, AND DETERGENT CONCENTRATES
