The amendment, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, to update the product label as PR Notice 2007-4, add an emergency contact number and align the First Aid and Precautionary Statements sections for label consistency, is acceptable, provided you make the following revisions:

Revise the Container Disposal to read as follows:

"Nonrefillable container. Do not reuse or refill the container. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration or by approved state and local authorities".

Kathon FP Concentrate microbicide is recommended for REFINERY AND TERMINAL USE ONLY. **METHOD OF ADDITION**: Kathon FP Concentrate microbicide should be directly dispensed into a fuel tank, storage tank, or flowing stream of fuel in a manner to ensure uniform distribution of the preservative in the fuel system. Slug dose or continuous feed methods are recommended.

**CURATIVE DOSE**: When the system is noticeably fouled, add 11-21 gallon of Kathon FP Concentrate microbicide per 1 million gallon of fluid in the system.
