This product is recommended for the control of bacteria and fungi in water-based printing inks such as flexographic, gravure, screen, and ink jet printing inks. Add 0.4-1.67 pound of this product (181-756 gram) to each 1000 pound of fluid to provide 400-1670 ppm product (6-25 ppm active isothiazolone).

This product is recommended for the control of bacteria and fungi in the manufacture and storage of printing ink components such as resins, plasticizers, water soluble dyes, pigments, gelling agents, waxes, surfactants, and thickeners. Add 0.4-1.67 pound of this product (181-756 gram) to each 1000 pound of fluid to provide 400-1670 ppm product (6-25 ppm active isothiazolone).

This product is recommended for the control of bacteria and fungi in fountain solutions used for lithographic printing operations. This product should only be used in those fountain solution concentrates which are automatically diluted prior to use.

This product is also recommended as a preservative for photoplate processing chemicals such as stabilizer solutions. This product should be added to the fountain solution concentrate or processing chemical concentrate at a level to ensure that the final use-dilution fluid will contain between 400-1670 ppm product (6-25 ppm active isothiazolone).

This product weighs 8.4 pound/gallon.
