Kathon TCP II is recommended for the control of bacteria and fungi in the manufacture and storage of textile processing chemicals such as fiber lubricants, spin finishes, sizes, dyestuffs, textile printing inks, dispersants, thickeners, dye fixatives, hand builders and weighters. These textile processing chemicals are commonly used in the production of natural and synthetic fibers and fabrics.

Add 0.4 - 1.67 pounds (181 - 757 grams) of Kathon TCP II to each 1,000 pounds of fluid to provide 400 - 1667 ppm product (6 - 25 ppm active isothiazolone).

Kathon TCP II weighs 8.4 pounds/gallon.
