Add 0.4 - 1.67 pounds (181 - 757 grams) of Kathon TCP II to each 1,000 pounds of fluid to provide 400 - 1667 ppm product (6 - 25 ppm active isothiazolone).

Kathon TCP II weighs 8.4 pounds/gallon.
