For use as an industrial microbicide in coatings such as latex and solvent-based paints, semi-transparent stains and solid stains. Use 0.08 - 0.37 pound of Kathon 930 Industrial Microbicide per 100 pound of coating formulation. If necessary, a higher dosage up to 0.67 pound of Kathon 930 Industrial Microbicide per 100 pound may be used depending upon level of control required.

In latex coatings, Kathon 930 Industrial Microbicide should be added during the letdown phase of paint manufacture.
