65 per 100 pounds of formulation.

### **BUILDING MATERIALS**

For use as a microbicide to control bacteria, algae and fungi in exterior building materials, stucco, caulks, and sealants. Use 0.25 - 2.0 pounds of Rocima 65 per 100 pounds of formulation.

If necessary, higher dosages, up to 3.0 pound of Rocima 65 per 100 pounds of coating or building material formulation, may be used depending on the level of control required.

Dosage levels of Rocima 65 will depend upon the type of formulation, the level of protection required, and the climate in which the

material will be exposed.
