INSECT CONTROL—ASPARAGUS BEETLES on Asparagus; BEAN APHIDS, BEAN LEAF BEETLES, MEXICAN BEAN BEETLES on Beans; CABBAGE LOOPERS on Beets, Cabbage, Collards, Lettuce, Spinach and Turnips; FLEA BEETLES on Beets, Cabbage, Collards, Eggplant, Lettuce, Radishes and Turnips; CABBAGE APHIDS on Cabbage, Collards, Lettuce, Spinach and Turnips; CROSS STRIPED CABBAGEWORMS, DIAMONDBACK MOTHS, IMPORTED CABBAGEWORMS, HARLEQUIN BUGS, VEGETABLE WEEVILS on Cabbage, Collards, Lettuce and Turnips; JAPANESE BEETLES on Peaches and Plums; SPIDER MITES on Apples and Pears.

DISEASE CONTROL—Begin applications before disease appears and repeat at seven to ten day intervals—BROWN ROT on Peaches, Plums and Prunes; POWDERY MILDEW on Beans, Cabbage, Collards, Eggplant, Lettuce, Spinach, Turnips, Apples, Grapes and Pears; RUST on Asparagus, Beets, Spinach, Apples and Pears; SCAB on Apples, Peaches, Pears and Plums.

DIRECTIONS

AS A DUST: Blow dust with strong blast directly into vines or through the plants covering them with a thin film of powder at the rate of 50 lbs. of dust per acre (1 lb. per 870 sq. ft.). For best results, apply in early morning or late afternoon and after heavy rains. Apply at weekly intervals during cloudy weather.

This product is compatible with neutral Bordeaux and lead or calcium arsenate. Not compatible with lime. Do not use on any sulphur sensitive plants — Melons, Cucumbers, Squash and Gourd.

CAUTION: Do not apply to the above mentioned crops within 1 day of harvest. Sulphur may burn foliage when temperatures are excessively high. This product is not compatible with lime. Do not use on sulphur sensitive plants. Do not use sulphur on Apple foliage, within 10-14 days of an oil spray. Do not reuse empty container. Destroy by burning; stay away from smoke or fumes. Avoid inhalation of dust or spray mist.
