Then broadcast Kwik-Kill Bait on the ground under plants and shrubs. Repeat application in one week to control new generation hatching from eggs in the ground and invasion from adjoining areas. Kwik-Kill Bait will not injure vegetation if used as directed. "Do not contaminate edible plant parts."

Each pound of Kwik-Kill Bait is sufficient for treating 200 square feet of surface area.

Kwik-Kill Bait, when applied to the soil surface around ornamentals and listed vegetable plants, will kill Cutworms, Slugs, Snails and will generally control moderate infestations of Sow Bugs.
