

FLAT-HEADED BORERS, ROUND-HEADED BORERS, PEACH TREE BORER: On Apples, Cherries, Peaches, use l tablespoonful to 1 gallon of water. Apply to trunk, crotch to ground. Soak bark to runoff and around base of tree. DO NOT APPLY TO FRUIT OR FOILAGE. pre-harvest intervals for apples and peaches is a 60 day.
