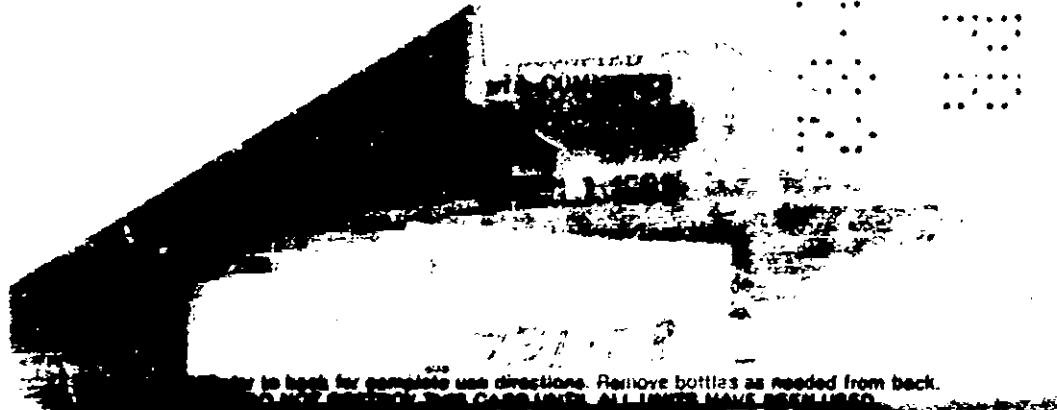

ON GROWING CROPS. While green manure crops can be used frequently, use is limited by the timing of harvest. Especially in the fall, green manure crops may not be used due to residue left in the field. After green manure crops are harvested, a residue of 5 to 6 tons/acre may be used in combination with other organic materials to improve soil conditions. Green manure crops can be plowed into the soil with a moldboard plow.
