POULTRY: to control poultry lice, and northern fewl mites, apply to litter at 1 pound per 40 square feet to control chicken red mites apply at 1 pound per 60 square feet. Put a tablespoon of dust in each nest and dust roosts individually. Repeat as necessary. Dust individual birds with shaker can, puff type or rotary hand duster for direct application when needed.

POULTRY DUSTING BOX: For control of northern fowl mites and poultry lice, place one self-treatment dust box (18 \times 12 \times 3 inches deep), containing one pound Stock & Poultry Dust per each 30 hens.
