

Directions for Use

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SWIMMING POOL USE

This calcium hypochlorite product contains a minimum of 65% available chlorine. These tablets are fastdissolving, blue chlorinating tablets that re-energize the protective Sustain[®] Summer Shield[®] and destroy organic contaminants to keep pool water clear and sparkling.

For any application method you choose: No one can be in the pool when chemicals are being added directly to the pool. Do not mix this product with other chemicals, including any other pool chemicals of any kind, such as other disinfection or "shock" products. Mixing could cause a fire or explosion. Always add this product into large quantities of water to fully dissolve. <u>Never add</u> water into product. Make sure to keep the pump and filter running during application and for at least 6 to 8 hours after application to allow for the best product dispersion. For best results, test your pool water prior to addition of this product and maintain pool water parameters in the ranges noted below.

This product will raise the pH of pool water. For best results, test your pool water prior to addition of this product. If your pH measures 7.4 or higher, adjust it downward so that it is between 7.2 to 7.4. This will help avoid clouding of water and allow for faster dispersion of the product.

APPLICATION METHOD:

(Use one of the following statements)

Use chlorinating tablets in a skimmer basket, a floating dispenser, skimmer dispenser or chlorinator to dispense tablets. Do not throw the tablets directly into the pool or allow tablets to contact plastic or steel pool linings.

OR

Clear out skimmer basket of any debris such as leaves or any other obstructions. Then, place [Sustain Energizer] chlorinating tablets directly into your pool's skimmer basket. Note: If you have a small skimmer basket you may have to remove your [Sustain 3"] skimmer cup to avoid water flow restriction. When [Energizer] tablets have dissolved, return the [Sustain 3"] skimmer cup to the basket.

HOW TO APPLY TO POOLS

REMINDER: Never add water to product. Always add product to large quantities of water to fully dissolve. Maintain operation of your pump and filter. Treatment should be done at night or during a period when the pool is not in use

Use 1 cup (8 oz.) of tablets for each 5,000 gallons of water. Clean skimmer basket and return basket to the skimmer. For smaller skimmer baskets you may need to take the 3" Chlorinating Tablet skimmer 'dispenser out of the skimmer basket while applying the PPG Shield Energizer tablets'. Add proper dosage of tablets with the circulating system running. Continue circulating for at least 5 hours. For the smaller skimmer, return the filled 3" Chlorinating tablet skimmer dispenser to the skimmer basket as soon as the PPG Shield Energizer tablets have dissolved. Do not use the pool until the free chlorine residual is 4 gpm or less as determined by using your Sustain 3-way test strips or DPD test. Use Sustain[®] Summer Shield[®] to help chlorine protect your pool from algae growth all season long.

[NOTE TO EPA: Optional Statements for Pool Maintenance:]

Add Sustain[®] Summer Shield[®], once each summer (150 days) to help chlorine protect your pool from algae growth all season long. Begin weekly additions of PPG Shield Energizer tablets to re-energize the protective Sustain[®] Summer Shield[®] and keep your pool water sparking clear. You must follow the use directions of these products.
