LIMA BEANS, SNAP BEANS, DRY BEANS: To control Downy Mildew, Anthracrose and Rust, apply at the rate of 30 pounds per acre. Begin applications when 5 to 10; of blooms show and continue at 7-day intervals as necessary. Do not apply to snap beans (String beans) within 4 days of harvest. For early season insect and disease control, use Maneb-Parathion-DDT Vegetable Dust and for combined insect and disease control anytime, use Vege-O-Gard.

TOMATOES: To control Early Blight, Late Blight, Anthracnose, Septoria Leaf Spot, and Gray Leaf Spot (Stemphylium), apply at the rate of 30 to 40 pounds per acre. Begin applications when first cluster fruit is well formed and repeat at 7 to 10-day intervals.

Earlier applications and more frequent applications may be necessary if disease conditions are unusually severe. For early season insect and disease control, use Maneb-Parathion-DDT Vegetable Dust and for combined insect and disease control anytime, use Vege-O-Gard.

Start applications when runners begin to form or at the first sign of disease. Repeat at weekly intervals. Direct dust to underside of leaves.
