

DIRECTIONS

To control fleas in pens, yards, lawns, barns and under buildings - apply this material at the rate of 1 to 2 pounds per 1,000 square feet using a garden-type duster. Treat in and around sleeping quarters, kennels and dog houses. Force dust into cracks and crevices.

Dust liberally. Repeat as necessary. Do not expose kittens less than four weeks of age to treated areas.

MOSQUITOES

For control of adult mosquitoes (outdoors only), apply to shrubbery, grass and other vegetation at the rate of 1 to 2 pounds per 1,000 square feet. Repeat as necessary for control.

TICKS

On infested lawns, vacant fields and wooded areas, apply this product at the rate of 1.2 to 1 pound per 1,000 square feet depending upon amount of ground cover and vegetation present. Apply to ground, surface litter and vegetation up to a height of about 2 feet. Repeat applications as necessary for control. Treat in and around sleeping quarters, kennels and dog houses as directed under fleas. Dust liberally.

MILLIPEDES AND EARWIGS

Apply 2 to 3 pounds per 1,000 square feet to soil surface and to mulch and debris around moist shady places where these pests are found.
