The amendment referred to above, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

- 1. Submit/cite all data required for registration/reregistration of your products under FIFRA section 3(c)(5) or 4(a) when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
- a. We note that you have deleted your first aid statements for dermal, ocular, and inhalation routes of exposure. You need to provide toxicity data and/or a rationale for eliminating these statement from this product's labeling. Note that EPA will issue a PR Notice revising first aid statements in the near future. The following are the revised statements that would be required for your product at this time. You may wish to incorporate these revisions at this time:

"IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center for treatment advice. IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice." Also, add the following statement near the first aid statements: "Have the product container or label with you when calling a poison control center or doctor or going for treatment."

- EPA recommends that these statements be boxed and bulleted to present the information in a clear, easy-to-read fashion.
- b. The precautionary statements on page 2 of the labeling should be revised to read as follows:
 "Harmful if swallowed, inhaled, or absorbed through the skin or eyes. Avoid contact with skin, eyes or clothing. Wear waterproof gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco." Also, move the text: "Do not contaminate feed, foodstuffs, . . . milk is stored or processed," from the precautionary statements to the Directions for Use.
- c. In the Note to Physician, add the following: "This product is an organophosphate which is a cholinesterase inhibitor."
- d. Move the second and third paragraphs under ENVIRONMENTAL HAZARDS to the DIRECTIONS FOR USE.
- e. Revise the retreatment statements to specify a maximum frequency of application, such as: ".
 . but not more than _____ times per _____."

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped label is enclosed for your records.


