Dear Ms. Schmidt:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Make the following changes to your label:
 - a) In the Precautionary Statements section, delete the following sentences: "Wash thoroughly after handling. Do not treat puppies and kittens under 4 weeks of age. Keep out of reach of children." These instructions are repetitious since they also appear in the User Safety Requirements box on the same page. The instructions "do not treat puppies and kittens under 4 weeks of age" conflicts with the "12 weeks of age" instructions found later in your Directions for Use.
 - b) Move the sentence "Dust bedding and doghouse using a shaker can or other dust applicator" from the Precautionary Statements section of your label to the DIRECTIONS FOR USE.
 - c) Your product label does not contain an Environmental Hazards statement. Please add an Environmental Hazards statement as follows:

- d) Move the paragraph located directly beneath the User Safety Requirements box ("Use this product only outside.....puppies under 12 weeks of age.") to the DIRECTIONS FOR USE section as required in the Agency letter dated 10/1/96.
- Delete the sentence "Apply at least once a week for best results" and replace it with "Do not repeat applications more than once a week."
- 2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
