a) In the sentence immediately above the Active Ingredient statement change the word "Pest" in the sentence to "Pets" so that it reads "Protect Your Pets-flea Scat contains Sevin, effective control for fleas and ticks".

b) In the heading "ENVIRONMENTAL HAZARDS" in the first sentence add the words "to aquatic" so that it reads "This pesticide is extremely toxic to aquatic and estuarine invertebrates".

2. Submit two copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use this product only outside or in a well-ventilated area. Wearing household latex or rubber gloves, dust entire animal, avoiding pet's eyes, nose, mouth and genital areas. Rub or brush pet's hair to work dust down to the skin. This product should not be applied by children. Do not use on pregnant dogs. Do not use on kittens or puppies under 12 weeks of age. Dust bedding and doghouse using a shaker can or other dust applicator.

Use Flea Scat 3 ways for best results.

(1) To control fleas and ticks on dogs and cats, dust entire cat or dog starting with the head and work back, making sure to rub powder down to skin.

(2) Discard old bedding and apply Flea Scat to fresh bedding.

DIRECTIONS FOR USE ON LAWNS

Wearing household latex or rubber gloves, use a dust applicator such as a shaker can, dust gun, puffer or other bulbous duster, rotary duster or other appropriate duster as available. Dust lightly to cover area with a thin, even film of dust. Apply when air is calm to avoid drift and contact with eyes and skin.

Start applying at the farthest corner of the treatment area and work backward to avoid contact with dusted surfaces. Allow dust to settle in treated areas before reentering.

STORAGE AND DISPOSAL
