

#### Dear Ms. Schmidt:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the following comments.

Topic	Action required
Ingredients	Add the following text following the ingredients list:  "Contains 4 pounds of chlorpyrifos per gallon."
First Aid	Replace current "If swallowed" text with the following text:  "IF SWALLOWED: Call a physician or poison control center immediately. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol."

Note to physician	<ol> <li>Remove "Note to Physician" which appears before the "First Aid" section. A similar note already appears in the correct location immediately following the first aid text.</li> <li>Add the following to the current note to</li> </ol>
	physician:  "Aromatic petroleum solvent may pose an
	aspiration pneumonia hazard."
Environmental Hazards	Replace current text in this section with the following:
	"This pesticide is toxic to birds and wildlift and extremely toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams ponds, estuaries, oceans, or other waters unless in accordance with the requirement of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. 	"Pest Control Indoors (Indoor): Crack and crevice, spot, and bait treatments in and around residential and non-residential buildings and structures (including food handling establishments) including, but not limited to, apartment buildings, bakeries, bottling facilities, breweries, cafeterias, food manufacturing plants, food processing plants, food service establishments, granaries and grain mills, hospitals, hotels, houses (including crawl spaces), industrial buildings, kitchens, laboratories, mausoleums, mobile and motor homes, offices, restaurants, schools, stores, warehouses, wineries, and vehicles."

Directions for Use - NOT INTO	Chlorpyrifos technical and manufacturing use products must include a list of certain uses for which the product may <u>not</u> be used. This is unusual for a pesticide label but was done as part of the risk reduction agreement with chlorpyrifos registrants in order to avoid any ambiguity regarding uses. Following the section listing sites for which the product may be used (see above) add the following text. This text may not be edited in any way and must appear in its entirety.
	"This product may NOT be used for formulation into manufacturing-use or enduse products for the following uses:
	Pest Control Indoors (Indoor): Indoor broadcast use; total release foggers for indoor residential and nonresidential (except greenhouse) use; coating products intended for large indoor surface areas such as floors, walls, and ceilings inside residential dwellings, offices, schools, or health care institutions including, but not limited to, houses, apartments, nursing homes, and patient rooms in hospitals.
	Pest and Domestic Animals (indoor): Animal dips, sprays, shampoos, dusts.
	Aquatic Uses (Aquatic Food Crop)(Aquatic Non-Food): Any aquatic use, including mosquito larvicide.
	Pest Control Indoors or Outdoors (Domestic Indoor or Outdoor): Paint additives, application in sewer manholes.
	All manufacturing-use products produced from this product must bear a statement prohibiting formulation of such products for the uses identified above."

Topic	Action required
Storage and Disposal - container disposal	Replace the current container disposal text with the following:
	"Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities."

Submit three (3) copies of your final printed labeling incorporating the above changes prior to releasing your product for shipment. If the above provisions are not complied with the registration will be subject to cancellation in accordance with FIFRA Section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A copy of your label stamped "accepted with comments" is enclosed for your records.

If On Skin: In case of contact, wash effected area with soap and water.

**If In Eyes:** Flush eyes with plenty of water. Get medical attention if irritation persists. **Note To Physician:** Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically Atropine, only by injection, is the preferable antidote.

This pesticide is extremely toxic to fish, birds and other wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries oceans, or public waters.
