STATEMENT OF PRACTICAL TREATMENT

GENERAL INFORMATION: Use SMCP Xtraban Insecticide as a crack and crevice treatment only to control Cockroaches, Ants, Crickets, Firebrats, Silverfish, Spiders and Brown Dog Ticks in and around residential buildings (such as houses, apartments, condominiums) and non-food/feed processing areas of institutional and commercial buildings (such as hospitals, stores, warehouses, schools, restaurants). Non-food/feed processing areas include garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage rooms (after canning or bottling). Dilute the required amount in water or in a base oil such as deodorized kerosene. Apply according to directions given for pests listed. Repeat the treatment as needed.

SPRAY DILUTION RATES

LOW RATE: For Insecticide Spray containing 0.25% Chlorpyrifos and 0.125% DDVP mix 2 oz. SMCP Xtraban Insecticide per gallon of water or base oil.

For Control Of Cockroaches (including strains resistant to certain other insecticides), Ants, Crickets, Firebrats, Silverfish, Spiders: Apply as a coarse spray or with a paint brush to localized areas where these pests are found or normally occur, including dark corners of rooms and closets, cracks and crevices in walls, along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations. For Ants: Apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

NOTE: A period of 4 - 7 days after treatment is normally required for maximum effect on cockroaches.

HIGH RATE: For Insecticide Spray containing 0.5% Chlorpyrifos and 0.25% DDVP mix 4 oz. SMCP Xtraban Insecticide per gallon of water or base oil. Use this higher concentrate to quickly reduce heavy infestations of Cockroaches, Ants, Crickets, Firebrats, Silverfish and Spiders. Apply to same areas as listed under "LOW RATE".

DIRECTIONS FOR APPLICATION WITHIN NON-FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS

Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas

when food is exposed or facility is in operation. Use as a spot treatment by applying as a coarse spray or with a paint brush to areas where cockroaches normally are found. Apply to baseboards, areas around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where insects hide or through which they may enter.
