Subject: Labeling Amendment SMCP 3.73% Pramitol Vegetation Killer EPA Reg. No. 769-713 Submission dated August 7, 2007

The labeling, referred to above, submitted in connection with the application under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes:

Your product is formulated in the liquid form.

1. Heading"

a. Add a statement on weight of prometon per gallon.

b. Change EPA Est. "44616-MO-1" to "769-MO-1."

2. Under "Signal Word"

Change "Caution" to "Warning." Our record does not indicate that you have not submitted acute toxicity studies for review and acceptance. The labels of products which contain similar concentrations of prometon have assigned a signal word of "Warning." If you have acute toxicity studies to support the word "Caution," please submit them for review.

3. Under "Precautionary Statements";

Change "Causes moderate eye irritation" to "Cause substantial but temporarily eye irritation."

4. Add a section on 'Personal Protective Equipment," and add the following requirements:

Page 2 EPA Reg. No. 769-713

- Applicators and other handlers must wear chemical resistant gloves made of waterproof materials, long sleeved shirt and pants, protective eyewear, shoes and socks.
- Follow the manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.
- 5. Under "Environmental Hazards";

Replace "by cleaning of equipment" with "equipment washwaters or rinsate."

6. Under "Directions for Use":

Add the following statements:

- Do not enter or allow others to enter the treated area until sprays have dried.
- Do not allow people or pets to touch treated plants until the sprays have dried.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

The amended label supersedes all previously accepted labels. A stamped copy of the revised label is enclosed for your records. Please submit one copy of your final printed labeling before you release the product for shipment.

It is recommended for killing existing weed and grasses and to prevent re-growth around buildings, storage areas, fences, pumps, machinery, fuel tanks, recreational areas, roadways, residential areas, guard rails, airports, military installations, highway medians, pipelines, railroads, lumberyards, rights-of-way, and industrial sites (such as cross connects, pedestals, transformers, vaults, burred cable closures, telephone booths, and fire plugs).

The following are a few common weeds and other vegetation that can be destroyed and regrowth prevented with the product: Oxalis, Crabgrass, Bermuda grass, Rye, Oats, Barley, Foxtail, Dog Fennel, Plantain, Spotted Spurge, Pigweed, Puncture Vine, Mustard, Watergrass, Green Ground Mold, Malva, Wild Turnip, Lambsquarters, and such hard to kill perennial weeds as Hoary Cress, Dandelion and Wild Morning Glory.

How To Apply: Uniformly spray one gallon of product in 10 gallons of water over 1,000 sq. ft. of soil surface. Thoroughly wet all foliage to insure contact action. Where vegetation is tall and dense, use 1 $\frac{1}{2}$ gallons of this product in 10 gallons of water per 1,000 square feet of soil surface. Use a tank sprayer or sprinkling can. Although this product has considerable activity through foliar contact, much of its activity is through the roots and therefore, adequate rainfall to move the chemical into the root zone is necessary. If no rain has fallen, two days after applying water the treated area deeply to increase plant absorption.
