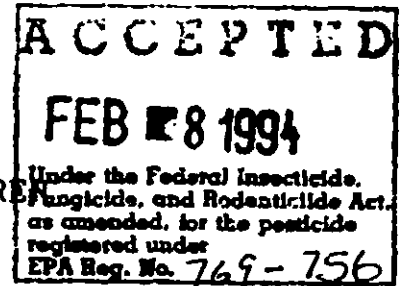


RESTRICTED USE PESTICIDE

PRECAUTIONARY STATEMENTS

Zinc Phosphide is highly toxic to all forms of animal life. Great care must be exercised in its use. Poisonous if swallowed. Do not breathe dust or fumes. Do not contaminate feed or foodstuffs. Keep away from children, irresponsible persons, and domestic animals. Avoid contact with skin. Wear rubber gloves when handling Zinc Phosphide and prepared baits. Wash thoroughly with soap and water after handling.

STATEMENT OF PRACTICAL TREATMENT

Any persons applying Zinc Phosphide products and experiencing signs and symptoms such as nausea, abdominal pain, tightness in the chest, or weakness, should be seen by a physician immediately.

IF SWALLOWED: Immediately call a Poison Control Center, or physician, or transport the patient to the nearest hospital. Do not drink water. Do not administer anything by mouth or make the patient vomit unless advised to do so by a physician.

IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water.

SUGGESTED PROCEDURE FOR SAFE DISPOSAL OF CAN:

DO NOT REUSE THIS CAN. Completely empty the contents and bury the unused chemical at least 18 inches deep in an isolated location away from water supplies. Pour one pint of water (or less if can is too small) into the empty can and add one tablespoon of household detergent. Rotate the can carefully to wet all inner surfaces with the solution. Bury the rinse solution at least 18 inches deep in an isolated location away from water supplies. Punch holes in the top and bottom of the can, crush the can and bury deeply in an isolated location.

Zinc Phosphide and baits prepared with it should be stored in tightly closed containers. All containers should be clearly labeled POISON and kept in a dry place out of the reach of children, pets and livestock. Not for use or storage in or around the home.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to wildlife and fish. Keep out of lakes, ponds, and streams. Do not contaminate water by cleaning of equipment or disposal of wastes.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS: Baits made from this product may be used to control meadow voles (Microtus pennsylvanicus), orchard voles (M. ochrogaster), and pine voles (M. pinetorum) in orchards and groves. Baits made from this product may only be applied after harvest, while the orchard or grove is in a nonbearing phase. Do not apply baits on bare ground or over growing crops. Do not graze animals in treated areas.

Wear an approved respirator and rubber gloves when mixing or handling this product or baits made from it.

MIXING DIRECTIONS: Prepare 1/2 inch apple-cube baits mixed so that they contain Zinc Phosphide at a concentration of about one percent. Gradually mix one ounce of this product for every 4 pounds of apple cubes used, stirring continuously. Keep this product, baits made from it, and contaminated mixing equipment out of reach of children.

Mix apple-cube baits in open areas. Wear rubber gloves and respiratory protection when mixing baits. As contents may become

compacted, thoroughly shake the Zinc Phosphide concentrate's container before opening it.

APPLICATION DIRECTIONS

Place 1 OR 2 treated apple cubes at each of 2-4 different locations in active vole trails near the base of each infested tree. Cover bait by pulling overhanging grass back into place. Do not disturb the runway system. Do not allow bait to be exposed on bare ground. Do not exceed the application rates specified on this label. Do not retreat the same area with Zinc Phosphide within 30 days of the conclusion of the previous baiting program.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store only in original container in a dry, acid-free place, inaccessible to children, pets, domestic animals and wildlife. Do not store around the home.

PESTICIDE DISPOSAL: Pesticides wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide and Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
