

Apply to all insect breeding sites and harborages. Also treat adjacent exposed surfaces where insects may crawl when they come out of hiding. Repeat treatment as necessary.

#### DIRECTIONS FOR USE

Applications of this product in the food areas of food-handling establishments other than as a crack and crevice treatment are not permitted.

FOOD-HANDLING ESTABLISHMENTS: Places other than private residences in which exposed food is held, processed, prepared or served. Food areas: Application limited to crack and crevice treatment only. Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas when food is exposed and facility is in operation (also would be considered a food area). Apply in small amounts directly into cracks and crevices using equipment capable of delivering a pinstream of insecticide, where Roaches, Waterbugs and Silverfish hide; in points between different elements construction; between equipment and floors; open-motor housing, junction or switch boxes. ANTS: Apply to trails and places where Ants enter premises such as window frames and door frames. Also spray ant hills and runways out-of-doors.

SILVERFISH: Apply to localized areas infested by these insects.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, SOWBUGS, SCORPIONS AND SPIDERS: Thoroughly spray interior and exterior perimeter of the infested premises. For Clover Mites, give special attention twindow frames.

FLEAS, FLIES, GNATS AND MOSQUITOES (OUTDOORS ONLY): Spray infested areas thoroughly outside. Treat outside surfaces of screens, doors, window frames, foundations, patios and other areas where insects may enter.
