In our May letter, we provided you with information on revising your Confidential Statement of Formula (CSF) and labeling.

I. Revised CSF

In your June 13, 1997 letter, you indicated that a revised CSF would follow under separate cover. Five months later, we have not received this document. Within 30 days of receipt of this letter, submit a revised CSF, including a valid source of active ingredient.

II. Revised Label

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, that:

A. you submit one (1) copy of the final printed labeling to us before you ship the product, with the following changes:


1. Delete "CONTAINS Pyrethrum & Rotenone Two Naturally Occurring Insecticides" because they would be considered to be false and misleading under 40 CFR 156.10(a)(5)(ix) & (x). As an alternative, you could put separate footnotes after each active ingredient in the ingredient statement. Acceptable wording for such footnotes could be:

- a. Rotenone, an active ingredient derived from the derris root.
- b. Pyrethrins, active ingredients derived from the Chrysanthemum flower.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of this condition.

A stamped copy of the labeling is enclosed for your records.

PESTS: Fleahoppers, certain Aphids, Spotted mites, Tarnished plant bugs, White flies when sprayed directly on the insects. Kills chewing insects such as Imported cabbage worm, Flea beetle, Rose slug, Rose chafer, Aster beetle.

1. Spray in evening or on cloudy day when air is still and insects first appear.
2. Shake gently before using.
3. Remove protective cap. Hold can upright, and point nozzle away from you.
4. Press button to spray.
5. Spray plants from a distance of 10 to 12 inches, spraying in short 1 or 2 second bursts.
6. Repeat treatment when insects reappear.
