Pratt Triple X NA Killer Non-Selective
EPA Reg. No. 769-898
Submission dated August 7, 2007

The labeling, referred to above, submitted in connection with the application under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes:

1. Heading"

- a. Add a statement on weight of prometon per gallon.
- b. Change EPA Est. "44616-MO-1" to "769-MO-1."

2. Under "First Aid"

Rearrange the treatment sequence as the following:

- If in eyes.
- If on skin or clothing.
- If swallowed.
- If inhaled.

3. Under "Precautionary Statements";

- Change "Cause eye damage" to "Causes irreversible eye damage." Add "Wear chemical goggles or face shield. Also, add "Remove and wash contaminated clothing before reuse" after "After using this product."
- Add "wear chemical goggles or face shield" and remove "It is recommended that safety glasses . . . temple protection."

4. It is recommended that you add the following use safety recommendation requirements:

- Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.
- Users should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

- Users should remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

5. Under "Environmental Hazards";

Add "or rinsate" after "Do not contaminant water when disposing equipment washwaters."

6. Under "Directions for Use":

Delete "Do not allow . . . dust has settled" with the following statements:

- Do not enter or allow others to enter the treated area until sprays have dried.
- Do not allow people or pets to touch treated plants until the sprays have dried.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

7. Under "Storage and Disposal";

Add instructions for pesticide disposal.

The amended label supersedes all previously accepted labels. A stamped copy of the revised label is enclosed for your records. Please submit one copy of your final printed labeling before you release the product for shipment.

PRECAUTIONARY STATEMENTS
Hazards to Humans and Domestic Animals

DANGER

Corrosive—causes eye damage. Causes skin irritation. Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing spray mist. Do not get in eyes, on skin or on clothing. Wash thoroughly after handling, before eating or smoking. Avoid contamination of food.

When using this product wear long-sleeved shirt, long pants, socks, shoes, chemical resistant gloves and eye protection. It is recommended that safety glasses included front, brow and temple protection.

After using this product, rinse gloves before removing, remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water. Remove saturated clothing as soon as possible and shower.

ENVIRONMENTAL HAZARDS

It is a violation of Federal law to use this product in a manner inconsistent with the label. Do not apply this product through any type of irrigation system. Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treatment area until spray has dried or dust has settled.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in tightly closed, original container in a locked area away from children and domestic animals. Do not store near fertilizer, seeds or other pesticides. Open dumping is prohibited.

PESTICIDE STORAGE: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. GENERAL USE DIRECTIONS

For total weed control around buildings, storage areas, fences, pumps, machinery, fuel tanks, recreational areas, roadways, residential areas, guard rails, airports, military installations, highway medians, pipelines, railroads, lumberyards, rights-of-way, and industrial sites (such as cross connects, pedestals, transformers, vaults, burred cable closures, telephone booths, and fire plugs). This product kills most young weeds and grass on contact and deposits a chemical

residue in the soil. This residue inhibits annual weed and grass seeds from germinating during the entire growing season. Contact activity will be apparent in a few days. Final kill by root penetration may take from 2 to 3 weeks. For best results on established weeds they must be actively growing with sufficient rainfall. Dry soil and insufficient rainfall will limit the translocation within the plant and prevent penetration into the soil.

For best results, apply in the early Spring before weeds germinate. If weeds have germinated, apply before they are four inches tall. Make only one application per year.

For general weed and grass control: Apply one (1) gallon of Triple X NA Weed Killer in 15 to 30 gallons of water to cover 3,380 square feet, or 1 ¼ quarts in 5 to 10 gallons of water per 1,000 square feet.

For areas where heavy grass and weed growth is present and where vegetation is more than 24 inches high, mow or cut to 8 inch height before applying. Use sufficient volume of spray to thoroughly cover all foliage.
