This amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable, provided that you:

- Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. On the front panel change "THIS PRODUCT IS FOR HOME LAWNS AND YARDS ONLY" to "FOR OUTDOOR USE ON THE HOME LAWN AND THE HOME GARDEN ONLY".
 - b. Revise "Active Ingredients" to "Active Ingredient".
 - c. Under STATEMENT OF PRACTICAL TREATMENT move "Call a physician or Poison Control central." to before "Drink 1

- d. Under STATEMENT OF PRACTICAL TREATMENT If swallowed: after "Drink 1 or 2 glasses of water and incuce vomiting by touching back of throat with finger." add "Repeat until vomit fluid is clear.".
- e. Replace the section under STATEMENT OF PRACTICAL TREATMENT If In Eyes: with "Rinse eyes with plenty of water and call a physician immediately.".
- f. Under STATEMENT OF PRACTICAL TREATMENT If Inhaled: add "and apply artificial respiration if indicated.".
- g. Replace the section under STATEMENT OF PRACTICAL Treatment If On Skin: with "Wash promptly with soap and water. Rinse thoroughly.".
- h. Under STATEMENT OF PRACTICAL TREATMENT at the end add "Note to Physician: This product is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal, 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.".
- i. Revise the first sentence to "Harmful if swallowed, inhaled or absorbed through skin.".
- j. Under Hazards To Humans And Domestic Animals after "May be absorbed through the skin." add "Avoid contamination of food and feed.".
- k. Under Hazards To Humans And Domestic Animals change "Avoid breathing dust." to "Avoid inhalation of dust.".
 - 1. Under Hazards To Humans And Domestic Animals replace "Do not contaminate...measuring this product." with "May cause sensitization following repeated contact with skin in susceptible individuals. Avoid repeated contact with skin. If sensitization reactions result, consult a physician.".
 - m. Under ENVIRONMENTAL HAZARDS change "Birds feeding on treated area may be killed." to read "Birds, especially waterfowl (ducks or geese) feeding or drinking on treated area may be killed. Because of the migratory habits of certain Atlantic Coast waterfowl, do not apply this product to lawns in Nassau County, New York, between November 1 and May 20. Do not exceed maximum permitted label rates. Application rates above those recommended significantly increase potential hazards to birds. For lawns, follow all watering instructions in the directions for use., however, stop watering before puddling occurs. For lawns, do not apply this product to sites occupied by waterfowl, or within 75 ft. of any body of water which may attract waterfowl, such as ponds or lakes. Keep out

of lakes, streams, ponds, tidal marshes, and estuaries. Do not apply directly to water. Runoff may be hazardous to fish and other aquatic organisms in neighboring areas. Shrimp and crab may be killed at application rates recommended on this label. Do not apply where fish, shrimp, crab and other aquatic life are important resources.".

- n. Under ENVIRONMENTAL HAZARDS delete "Do not apply when weather conditions... and the next period of bee activity.".
- o. Replace Storage and Disposal section with **Storage:** Store in original container in a cool, dry, well-ventilated area. store product in an area inaccessible to children and domestic animals. Do not store near fertilizers, herbicides, other insecticides, seeds, food, or feed. **Pesticide Disposal:** Securely wrap criginal container in several layers of newspaper and discard in trash. **Container Disposal:** Do not reuse empty container. Discard container in trash.".
- p. Under DIRECTIONS FOR USE enclose in a box with the heading OVERALL LAWN APPLICATION the following statements

"Special Precautions To reduce Risk To Birds Birds, especially waterfowl (ducks or geese) feeding or drinking on treated areas may be killed. To reduce risks to birds:

- 1. Do not treat areas larger than 15,00 sq. ft..
 - 2. Because of the migratory habits of certain waterfowl, do not apply in Nassau County, New York between November 1 and May 20.
 - 3. Do not exceed maximum permitted label rates, since rates above those recommended significantly increase potential hazards to birds, especially waterfowl.
 - 4. Avoid overlapping treated areas.
 - 5. Follow all watering instructions in the directions for use, however, stop watering before puddling occurs.
 - 6. Do not apply this product to sites occupied by waterfowl or to sites within 75 ft. of any body of water that may attract waterfowl, such as lakes or ponds.
 - 7. If it is necessary to repeat application, wait a minimum of 3 weeks between application. Make no more than 4 applications per year.".
 - q. Under LAWN INSECTS chinch bugs: delete "Use 6 oz."

Only one rate is now permitted regardless of the type of grass.

- p. Revise "Bermuda Mites" to "Bermudagrass Mites" and "Ticks" to "Brown Dog Ticks". The ants digger wasp directions should appear as a separate paragraph. Add precautions for digger wasp application.
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

Ants, Armyworms, Clover Mites, Collembola (springtails), Crickets, Cutworms, Earwigs, Frit Flies, Billbugs, Lawn Moth (sod webworm) use 4 oz. (16 tbsp.).

Bermuda Mites, Chiggers, Fleas, Leafhoppers, Ticks use 1 1/4 oz. (5 tbsp.) Ants, Digger Wasps dust directly onto ant hills and into wasp ground nest openings.
