



For use along driveways, sidewalks, fence lines, patios, and parking lots. Apply anytime during the growing season. Shake well. Invert the container, holding it away from the body to avoid contact with skin or clothing. Apply Liquid Edger to thoroughly wet foliage of unwanted vegetation. Avoid unnecessary runoff. The width of the sprinkling pattern may be adjusted by raising or lowering the container. Maximum control will be achieved during warm sunny weather and when unwanted vegetation is actively growing. SPOT TREATMENT:

To kill unwanted vegetation along side walks, patios, driveways, fences, retaining walls, around shrubs, trees, and bushes. Shake well. Use as provided for spot treatment of weeds. Adjust nozzle to give a coarse spray. Aim at center of weed and spray for thorough wetting and complete coverage of all unwanted vegetation. For tall weeds or grasses, cover foliage thoroughly and repeat in 5 days if necessary. LAWN RENOVATION
