### HOW TO APPLY

Hold card in upright position. Point tip of tube cap up and away from the user's face and body, then cut along dotted line. Invert card over dog and use point of card to part the hair of dog. Squeeze the tube firmly to apply all of the solution to the dog's skin. Wrap container and put in trash.

#### Dosage for Dogs Weighing Less Than 33 Pounds:

Apply 1 (one) cc of Defend® EXspot® insecticide solution to the skin of the dog's back between the shoulder blades.
