- 3. In the First Aid Statements, change "If On Skin" to "If On Skin or Clothing" as specified in PR Notice 2001-1.
- 4. In the "Storage and Disposal" section, delete the "Pesticide Disposal" instructions and change the heading "Container Disposal" to "Disposal" in accordance with PR Notice 2001-6.


