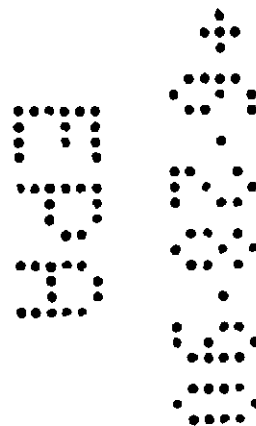

1. Raise the toilet seat. Flush toilet to wet surfaces. Remove cap and pour 1/2 cup (4 oz.) of LYSOL Brand Disinfectant Toilet Bowl Cleaner Crystals directly on sides of bowl, letting it fall down into water.
 2. After bubbling has stopped, let stand for a few minutes. Brush thoroughly and flush again.
 3. For deep stains repeat and let stand for 15 minutes before brushing.
- Close cap securely after each use. Rinse brush in clean water after use.

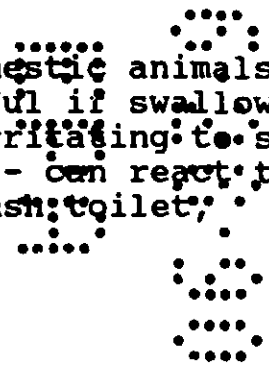

If on skin: Flood surfaces immediately with water, wash fully with soap. Cover area with milk of magnesia or moist baking soda.
