SHAKE WELL BEFORE USE

- . For general disinfection on precleaned hard non-porous inanimate environmental surfaces, eliminating odors, deodorization and air sanitization.

Directions for Use:

It is a violation to use this product in a manner inconsistent with its labeling.

To Eliminate Odors and Sanitize the Air:

Hold upright, spray towards ceiling while walking around room (doors and windows closed) allowing 10 seconds for every 1,000 cubic feet -- room about 11 ft. x 11 ft. x 9 ft. In larger rooms spray for proportionately longer period -- temporarily reduces air borne bacteria. Removes household, cooking, bathroom and pet odors -- spraying in smoke filled rooms leaves air smelling fresh and clean. To eliminate smoking odors retained in fabrics, spray around draperies, curtains and upholstered furniture.

To Disinfect Surfaces:

Clean surface prior to treatment. Hold container 6 to 8 inches from surface and spray until surface is moist. Allow surface to remain wet for 10 minutes. Do not use on polished wood or plastic surfaces. Germ caused odors are eliminated at their source. Acts wherever odor causing germs occur -- under sinks, in toilet areas, sick rooms, diaper pails, empty hampers, garbage and waste containers. Helps kill many potentially dangerous germs on toilet seats, bathroom basins, telephones, bed springs, pet pens and similar surfaces. Helps disinfect air ducts, animal areas and hard to reach places. Reduces the hazard of cross contamination by environmental surfaces.

To Freshen the Air:

Hold upright. Spray center of the room for 1 - 2 seconds.

To Control Mold and Mildew:

Clean hard non-porous surfaces prior to treatment. Spray surface until moist in all damp or musty areas and especially in bathrooms, laundry rooms, basements, shower stalls, attic crawl spaces, garages, waterfront homes, boat and automobile interiors -- repeat weekly or as necessary to maintain control. For mold and mildew on mattresses, shower curtains, pillows and books, spray surfaces and repeat every 2 weeks to maintain control.

- e. Delete the statement (right panel):

Avoid contact of skin with spray or with surfaces wet with spray.

f. Include the appropriate EPA Establishment No.

g. Note that we have revised the word Freshener to read Refreshener in your product name. We have adjusted our records accordingly.
