g. Revise "... cleaner kills Staphylococcus, Streptococcus and Salmonella germs..." to read "... cleaner kills Staphylococcus aureus, Streptococcus faecalis and Salmonella choleraesuis..."

h. Revise "...hard, nonporous surfaces.." to read "...hard, nonporous inanimate environmental surfaces.."

i. Revise the statement: "Causes eye irritation. Do not get in eyes. Avoid contact with ski." to read: "Causes eye irritation. Do not get in eyes, on skin or clothing. Harmful if swallowed. Avoid contamination of food. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

NOTE: Regardless of the individual results of the toxicity data submitted, the eye irritation study which is tox category II, drives the appropriate precautionary labeling statements.

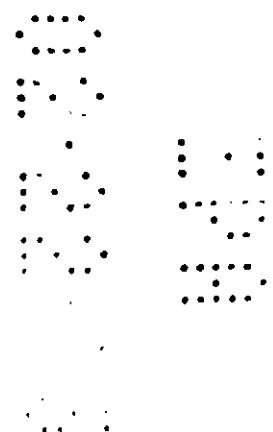

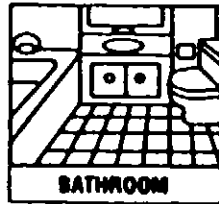
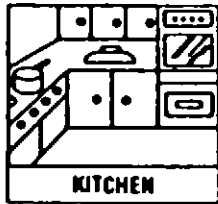

**Where To Use:**

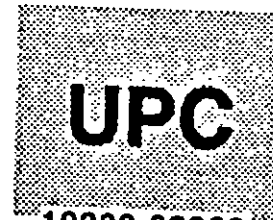
