Labeling Comments:

- a. Revise the EPA Registration Number to read, "EPA Reg. No. 777-112".
- b. On Page 1 of the proposed label delete references to "contains no ammonia and silicones"; it is a misleading statement in accordance with 40 CFR 156.10 (a)(5).
- c. On page 2 of the proposed label for all occurrences of (X%) you must specify the percentage.
- d. On page 2 and page 4 of the proposed label remove all references to "other wipes" and "leading wipes"; it is a comparative statement in accordance with 40 CFR 156.10 (a)(5).
- e. On page 5 of the proposed label remove "for a healthier institution"; implies a public heath claim and is not acceptable.
- f. On page 6 of the proposed label remove "Works as well as traditional/conventional cleaners"; it is a comparative statement in accordance with 40 CFR 156.10 (a)(5).
- g. On page 8 and 12 revise the qualifier claims by deleting the following allergens, "cat allergens, cockroach allergens, dog allergens, dust mite allergens, pet allergens, and pollen allergens." These terms are too broad, and they imply that "living" animals and insects are the allergens. You may add "pollen" among your list of Non-living Allergens".

Efficacy Comments:

1. The proposed label claims that the pre-saturated towelette product, Rosemary W, is an effective sanitizer against the following microorganisms on hard, non-porous, non-food contact surfaces for a 30-second contact time:

Staphylococcus aureus
Enterococcus aerogenes
Escherichia coli O157:H7
Salmonella enterica
Methicillin Resistant Staphylococcus aureus (MRSA)

- a. Note that the references to *E-coli* must be deleted from pages 7 and 11 of the proposed label, or replaced with references to *Escherichia coli* O157:H7.
- b. On pages 4, 6, and 7 of the proposed label, delete references to "one-step" cleaning. Revise to read: "one step sanitizing".
- c. On page 7 the proposed label, delete "bactericidal," as it implies that the product is a disinfectant.
- d. On page 8 of the proposed label, change "in 10 minutes" to read "in 30 seconds."
- e. On page 12 of the proposed label, delete the reference to "brass". Page 10 of the proposed label states that the product is not recommended for use on brass surfaces.
- f. On page 12 of the proposed label, change "enamel" to read "baked enamel". Enamel is a porous surface.
- g. On page 12 of the proposed label, delete the reference to "ceramic". Ceramic is a porous surface. Glazed ceramic is included in the list of surface types.



- h. On page 12 of the proposed label, change "granite" to read "sealed granite." Granite is a porous surface.
- i. On page 12 of the proposed label, change "terra cotta" to read "sealed terra cotta". Terra cotta is a porous surface.
- j. On page 12 of the proposed label, change "vinyl" to read "waxed vinyl". Page 10 of the proposed label states that the product is not recommended for use on unwaxed vinyl.
- k. On page 12 of the proposed label, change "tiles" to read "glazed tiles."
- I. Under the "Terminal Sterilant Statement" on page 13 of the proposed label, change otherwise enters" to read "otherwise enter".
- m. Under the "Disposal" section for professional containers on page 14 of the proposed label, add the following (or a similar) statement: "If recycling is not available, discard container in trash."
- 2. The following revision to EPA Form 8570-34 (Certification with Respect to Citation of Data) must be made: Under the applicant's address, change "300 Interpace Pkwy" to read "399 Interpace Pkwy".
