

Ticks, only an occasional problem on cats, are killed more slowly, but usually will be dead in 1 to 5 days, Collar will continue to aid in tick control for 30 days. Dead ticks occasionally remaining in cat's coat are easily detached. For best results, remove hard-to-kill ticks inside ears when Collar is put on.
