**IMPORTANT CONSUMER INFORMATION**

**PURPOSE:** Sergeant's® Household Flea & Tick Killer is specially formulated for use by pet owners as a quick killing ectoparasiticide to control fleas and ticks where your pet sleeps and plays. Use on pet bedding and sleeping quarters, as well as household rugs, upholstery and curtains where fleas and ticks may hide and breed. It is a residual spray that lasts for weeks killing Fleas, Ticks, Crickets, Ants and Spiders in and around Homes, Apartments and Garages. Respray these same areas as needed. Fleas and ticks are a common problem in houses with pets such as dogs or cats, so regular treatment will be necessary to control these insects.

**DIRECTIONS:** It is a violation of Federal law to use this product in a manner inconsistent with its labeling. To operate hold upright, point nozzle toward the surface to be treated and squeeze trigger.

**To kill Fleas and Ticks:** Apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters, and nearby cracks and crevices. Spray along and behind baseboards, window frames and localized areas of floor, rugs, upholstered furniture and curtains where these pests may be present. Fresh bedding should be placed in animal quarters following treatment.

**Do not spray pets with this product.** Treat dogs and cats with Sergeant's brand flea and tick products before allowing them to reenter treated area.

**STORAGE AND DISPOSAL:** Store in a cool area away from heat or open flame. Do not reuse empty container. Wrap container and put in trash collection.
