


## STATEMENT OF PRACTICAL TREATMENT

To control Leafhoppers, Thrips, and Plant Lice (Aphids) on Roses, Azaleas, Carnations, Chrysanthemums, Gladiolus, Peonies, Zinnias and Ornamental Turf Grasses.

Make application after first sprinkling area to be treated with water or when flowers or grass are damp after rainfall or dew has settled. Apply F&B Tobacco Dust thoroughly to both sides of moistened leaf surfaces sufficiently so as to insure contact of the dust with the bodies of insects. Apply 1 lb. to approximately 50 square feet of area to be treated. Repeat application at 7 to 10 day intervals.
