We have reviewed the above submissions and have the following comments on your cat protocols, toxicity testing, package sizes, and labeling.

A. Cat Protocols

Since your June 14, 1995, version of your cat protocol replaced the one sent February 22, 1995, we only reviewed the June 1995 version, which appears to be a reasonable outline of the testing needed to determine the efficacy of the product for cats. See our enclosure entitled "Review of 6/14/95 Cat Efficacy Protocol" for our detailed comments.

B. Toxicity Testing

1. Your acute oral test (MRID No. 435232-01), which showed a Category 4 toxicity, is acceptable.
2. Your Dermal Sensitization Test (MRID No. 426400-01) showed that the product was not a sensitizer.
3. Your waiver of the inhalation test was unacceptable. See enclosed toxicity review. Submit a new test or better rationale.

C. Package Sizes

D. Labeling

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you submit three (3) copies of revised labeling with the following changes:

1. Revise your Precautionary Statements as follows:

Precautionary Statements

Hazards to Humans and Domestic Animals

CAUTION

Avoid contact with eyes, skin and clothing. Do not inhale dust.

First Aid

IF ON SKIN: Wash promptly with soap and water. Get medical attention if irritation persists

2. If you have package sizes other than 3lb one, modify the length portion of the statement "will produce a band of product two inches wide and 85 feet long" to reflect how many feet one package would cover, assuming a 2 inch band width.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). You will have 18 months to begin using the new labels. Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Use Restrictions: This product may be used to discourage domestic dogs (*Canis familiaris*) from defecating on or near treated lawns or in treated areas around ornamental plants, trees, shrubs and pavements. This product also may be used to repel cottontail rabbits (*Sylvilagus floridanus*) from entering, feeding in, or defecating within treated areas associated with flower gardens, ornamental plants, trees and shrubs.

DO NOT USE THIS PRODUCT IN VEGETABLE GARDENS NOR ON FOOD CROPS. May be used around the perimeter of vegetable gardens. Do not allow the product to wind drift to nearby food crops.

Application Directions: Before treatment, try to remove all traces of animal droppings and urine from the areas to be protected. Animals are attracted by the odors of these deposits. If the odors are effectively removed, regular use of F&B Rabbit and Dog Chaser around ornamental plants, trees and shrubs should discourage new defecations by dogs and visitation by rabbits.

Apply this product in bands 2 or more inches wide around the plants or the areas to be protected. Be careful not to apply product directly to foliage or stems. Repeat treatment as needed. More frequent applications will be needed if heavy rains, heavy snowfalls, hot weather or high winds occur.

The material in this package (3 lbs.) will produce a band of product approximately 2 inches wide and 85 feet long.
