

ABGRASS CONTROL-Apply 15 lbs. per 1,000 sq. ft. of awns and ornamental turf to suppress crabgrass seedlings before germination or sprouting occurs. It is for use as an early season preventative of ustablished crabgrass plants. Timing of application is important and should be applied before any germination which in many areas is during the period April 15 to May 1. This treatment will not burn or injure established lawns.

### DO NOT USE ON NEWLY SEEDED LAWNS

SPOT TREATMENT: Late winter application to infested patches may be as effective as spring application. For spot treatment apply 1 1/2 lbs. per 100 sq. ft.

HELPFUL HINTS: After crabgrass seedlings have been suppressed by the Chlordane treatment, control may be assisted by:

- 1. Mowing the lawn to 1 1/2 to 2 inches.
- 2. Using an adequate quantity of fertilizer to maintain active growth.

INSECT CONTROL ON HOME LAWNS: For the control of the above listed insects on home lawns apply 50 lbs, per acre (1 1/4 lbs. per 1,000 sq. ft.) to cover surface uniformly, using a lawn fertilizer spreader. Treatment should be applied in the spring, or when insects are observed to be troublesome. Immediately after treatment, drench town with water or sprinkle heavily to make treatment nioreeffective and to reduce the hazard to children and pets Do not treat when soil is wet. Apply before ruin or sprinkling.
